### 8:00 P.M. OPEN PUBLIC MEETING MINUTES

On December 15, 2022 at 8:00 P.M., the Mayor and Council of the Borough of Midland Park conducted a meeting at Borough Hall in the Council Chambers located at 280 Godwin Avenue as previously advertised. Agenda items for the meeting were also listed on the Borough website. Mayor Shortway called the meeting to order, noting the date as December 15, 2022, and that there will be a 3-minute limit to each individual addressing the Governing Body during the Open Public portions of the meeting.

### **APPROVAL OF MINUTES:**

No Minutes for approval at this time.

### **OPEN TO THE PUBLIC:**

Mayor Shortway opened the meeting to the public for general questions, concerns, and comments.

Thomas Locicero, owner of All Points Towing, 30 Olden Road, Paramus, NJ – made a plea to the Mayor and Council to amend the Borough's towing ordinance. Mr. Locicero gave a list of towns that have or are considering amending their ordinances. With the increase in gas prices and the cost of materials, the prices that are listed in Midland Park's Towing Ordinances are outdated. The New Jersey State Police towing contract has higher rates than the Borough's. The Governing Body directed Borough Administrator/Clerk Wendy Martin to contact Police Chief Michael Powderley to research matter.

There being no one else from the Public and/or no callers were on the telephone, the Public Hearing was closed.

### **LIAISON REPORTS:**

Mayor Shortway attended the Bergen County Mayors' Association in Hackensack. The guest speaker was the new President and Chief Executive Officer Deborah Visconi, a representative from New Bridge Medical Center, Paramus, NJ, Ms. Visconiwho spoke of the services their facility offers to the residents of Bergen County.

Councilman DeBlasio Recreation/Information Technology/Municipal Alliance Councilman DeBlasio was absent. No report was given at this time.

Councilman Damiano Finance/Public Works/Chamber of Commerce/Economic Development Councilman Damiano noted there was progress reported for Finance, the Chamber of Commerce, and the Economic Development committees and/or departments. The Department of Public Works has completed the fall leaf cleanup program. The Councilman thanked the Public Works staff for an outstanding job on keeping the Borough's streets clean and safe.

## Planning Board/Building Dept/Fire Prevention/OEM

Councilman Kruis stated the year-to-date Fire Prevention inspections completed were 504. Fire Official Michael Rau attended the Bergen County Fire Prevention seminar in Closter, NJ which included classes related to fire inspections, escapes routes, and certifications. Mr. Rau has completed the collection of all keys for the Midland Park Shopping Center Knox Box. The Office of Emergency Management State Division offered a seminar for winter storm training. The Planning Board's meeting is scheduled for next week. The Building Department reported progress for the month of December.

## Public Safety - Fire/Ambulance/Library

Councilwoman DeLuca stated the Ambulance Corps held their annual holiday gathering. On December 10, 2022, the Fire Department's Breakfast with Santa was a success in the community along with the donations for Toys for Tots. Project Santa's popularity has increased through the years with many more stops and requests. The Junior Fire Department program will be launched after the holidays. For more information, please visit the Borough's website. The Library Board's meeting has been scheduled for December 20, 2022. Library Director Catherine Dileo reported 68% increase in foot traffic in the Library from the previous year.

### **Council President Peet**

### Board of Health/Board of Education/Ridgewood Water

Council President Peet The meeting of the Board of Education was held on December 13, 2022. At this regular meeting items such as: personnel items, finance motions, and curriculum changes were discussed. The Council President announced the BOE, Mayor Shortway, Jr., Councilwoman DeLuca and Borough Administrator/Clerk Wendy Martin are meeting in the month of January to further discuss the handling of the Sunset fields. The Board of Health reports there is progress and will be meeting in the following month. At the NorthWest Bergen Regional Health Commission, a grant of \$615,000.00 was awarded from the State of New Jersey Department of Health. On December 9, 2022, Council President met with the Borough of Glen Rock and the Township of Wyckoff concerning the bond issues our municipalities will be facing for the connections of the lead pipe replacements. Township of Wyckoff's Administrator Matthew A. Cavallo is representing the three (3) municipalities to Ridgewood Water. Mr. Cavallo is constructing an email detailing the municipalities needs for bonding and administrative fees connected to the project. These are just the initial stages of this development. When more information is available, the public will be advised. The participating municipalities met to continue discussions how bonding will be handled for the remediations of the lead line replacements in the communities. Midland Park currently knows of 207 homes that are affected by the lead lines and more discovery is ongoing. If the homeowner sells their home, the lead line replacement must be addressed by the owner or buyer.

## ADMINISTRATOR'S REPORT:

Borough Administrator/Clerk Wendy Martin reminded the Mayor and Council of an invitation to attend the Joint Insurance Fund Reorganization Meeting on January 19, 2023. On the Consent Agenda, there is a Resolution #210-2022 for a Community Development Block Grant Application relative to Road Resurfacing of Bank Street. This Resolution has been complied with the assistance of the Borough Engineer, Schwanewede and Hals Engineering. Ms. Martin received a response from Boy Scouts Gideon Eliya requesting to digitize

the Borough's historical documents. Council President Peet and Councilwoman DeLuca discussed the importance of the handling of these fragile documents and perhaps this action should be done by professionals. The Council agreed to not have the Boy Scouts handle the Borough's historic documents. They wished success upon Mr. Eliya with obtaining his Eagle Scouts' award. Ms. Martin will contact him of the Council decision.
