7:00 P.M. –Work Session Minutes

Mayor Shortway called the Meeting to Order at 7:00 P.M.

The Mayor read the Sunshine Law Statement: This meeting is being held in accordance with the Sunshine Law, notice having been published according to law with a copy on file in the Borough Clerk's Office and a copy posted on the bulletin board in the Municipal Building.

DISCUSSION ITEMS:

- 1. Sign Ordinance – Administrator Seemon** updated the Governing Body relative to the process he has put in place with Zoning Official Mark Berninger. Letters will be sent to any business owner that has a sign in the public right of way stating they need to be removed according to the cur ordinance. Also included in the letter will be the Borough's intent, within 30 days, to introduce and adopt a new ordinance relative to signs.
- 2. Open Space Project Ideas- Administrator Seemon** advised the Governing Body that he must put together a letter of intent for Open Space Projects. The Administrator suggested upgrading the playground equipment at the Dairy Street park, not the ADA equipment as that is relatively new. The older equipment there is becoming costly to replace or repair. **Councilwoman Peet** suggest a specific area near the "digger" be revamped. The **Administrator** also noted there was talk of dugout upgrades however we have more long-term goals therefore we should not be putting anything up that could potentially have to be taken down. **Councilman Sansone** also suggested building pads for the school's old bleachers that have been given to the Borough. The **Administrator** stated he would investigate it, construction like this which is permanent does not usually get approved for Open Space. Councilman Kamp inquired if there is a maximum you can ask for? **Administrator Seemon** noted Franklin Lakes received a lot for turf fields. **Councilwoman Peet** inquired about turfing our fields, **Administrator Seemon** stated we would not get enough money. **Councilman Sansone** reiterated having a non-binding referendum Question relative to turf fields will give us a better understanding of what the community wants.
