DISCUSSION ITEM:

1. Sample Resolution - National Gun Violence Awareness Day

Borough Administrator/Clerk Wendy Martin inquired if the **Mayor** and **Council** would like to pass a resolution supporting "National Gun Violence Awareness Day". The **Mayor** and majority of the **Council** wished not to pass any resolution.

2. Draft Ordinance - Zoning Certificate

Borough Administrator/Clerk Wendy Martin updated the Governing Body on the history of this proposed ordinance. This ordinance gives authority to the Zoning Official to revoke a Zoning Certificate should the business violate any portion of the Borough code.

3. 90 Midland Avenue

Borough Attorney Robert Regan gave testimony on the events involving 90 Midland Avenue. A redevelopment study was completed at the request of the Planning Board by the Planner. A hearing was held in the past week where it was approved and directed to prepare a resolution for a vote. The study is available for public record and review. Also, the Fire Prevention Official did an inspection of the property and declared the area safe.
