## ZONING PERMIT GENERAL INFORMATION

### FENCES:

- Fences require Zoning permits only
- If the fence encloses a pool or hot tub, it requires a UCC building permit.
- Fences located from the rear of the building to the front property line may be up to four feet (4') in height
- Fences located from the rear of the building to the rear property line may be up to five feet (5') in height
- The "Good Side" of the fence, if applicable, must face outward from your property
