Mayor Shortway called the meeting to order, noting the date as February 24, 2022, and that there will be a 3-minute limit to each individual addressing the Governing Body during the Open Public portions of the meeting.

OPEN TO THE PUBLIC:

The **Mayor** opened the meeting to the public for general questions, concerns, and comments.

Administrator/Clerk Martin asked members of the public present and on the phone to speak at this time.

No one from the Public came forward.

LIAISON REPORTS:

Mayor Shortway stated on Wednesday, February 23, 2022, the Mayor had the pleasure of swearing in Captain Chad Miller and Lieutenant Steven Rau at Borough Hall.

Councilman Damiano Finance/Public Works/Chamber of Commerce

Finance and the Chamber of Commerce reports progress. **Councilman Damiano** was informed by Matthew Tauber that 15 catch basin heads have been changed to conform to the Department of Environmental Protection standards. Superintendent Matthew Tauber also stated the **Department of Public Works** staff has attended several training sessions such as: employee conduct and violence prevention, woodchipper safety, playground safety inspections, CDL safety regulations, and ethical decision making. DPW continues to disinfect all Borough buildings. The staff is ready for tonight's winter weather. Mr. Tauber has predicted 2 to 3 inches of slush.

Councilman Iannone Public Safety – Police/Property Maintenance/Personnel Property Maintenance has experienced (3) vehicle complaints since the last **Mayor and Council** meeting. CVS has been notified of a dumpster complaint in the parking lot. Sanitation has been notified. There are (5) open property issues which John Torry, the Property Maintenance Official is continuing to resolve. The **Police Department** had officers investigated a shoplifting complaint, a restraining order, suspicious activity reports, one missing adult male who was later found in Paterson, one vehicle theft later located in North Bergen. Chief Powderley wanted to inform our residents that auto theft is up 84% in Bergen County in the current year 2022. 346% up for high end vehicles in the State of New Jersey as well. A public announcement for Midland Park citizens is to keep your vehicles locked, do not have valuables visible to the outside, and do not leave auto FOBs in the vehicles. Progress was reported for **Personnel.**

Councilman Kruis Planning Board/Building Dept/Fire Prevention/OEM

The **Planning Board** will have their meeting on February 28, 2022. The **Councilman** had a meeting with Mark Berninger, Construction and Zoning Official, and reported that the **Building Department** has progress. Michael Rau, **Fire Prevention/OEM** states there are 509 inspections due for 2022. 44 inspections have been done since the beginning of the year. Mr. Rau noted \$158,968.00 has been submitted through the CARES Act and the Borough has received \$135,825.00. Midland Park's inventory for PPE is at a satisfactory level and there are no future purchases needed at this time.

Councilwoman DeLuca Public Safety – Fire/Ambulance/Library

The **Ambulance Corps** meeting is scheduled for Monday, March 7, 2022. President Steve Holder stated, "**Midland Park Ambulance Corps** is alive and well and happy we are able to serve the town." Fire Chief Matthew Tauber indicated the next **Fire Department** meeting will be held on Wednesday, March 9, 2022. The **Library Board's** meeting was held on Tuesday, February 15, 2022. In response to **Councilman Damiano**, Library Director Catherine Dileo answered the (3) questions the Councilman asked at the last month's **Mayor and Council** meeting. The Library's ongoing projects included: adult section and collection – completing the fiction section of purging out

noncirculating books, children's story time, held a meeting for the Special Olympics Young Athletes and started registration, Grab and Go Crafts, the extremely popular, "Battle of the Books" in conjunction with the schools, and BCCLS Trustee Training program hours for State aid.

Council President Peet Board of Health/ Board of Education/Ridgewood Water Council President Peet stated the Ridgewood Water, which services Midland Park, Glen Rock Ridgewood, and Wyckoff, sent the Council President a certified notice for lead service line. The **Council President** recapped the letter and notified the public of a link where a resident can find more information and maps on this subject. There are 1119 homes in the four communities with verified lead in their pipes and 3800 that are at an unknown status. The cost of \$15 million dollars (\$10,000.00 per home) is projected for Ridgewood Water over the next 10 years. The replacement of pipes is not mandatory but optional for residents. Only Ridgewood residents may receive an assessment since Ridgewood Water does not have jurisdiction over Midland Park, Wyckoff, or Glen Rock. Midland Park's residents may have an issue if/when they sell their home. Council President **Peet** discussed the road paving project and the effects the water pipe replacements may have on the quality and disturbance of the roads. The Board of Health reported 292 positive Omicron COVID-19 cases since the beginning of 2022. The Board of Education held a seminar that is provided to high school seniors for college application process. The event was well attended. There has been several Bills in motion concerning New Jersey schools. One Bill is pending that would aide towns and the creation of regional schools. On March 8, 2022, the Special Election for the public question for the approval for the school's turf field will be held.

Councilman DeBlasio Recreation/Information Technology/Municipal Alliance Kathy LaMonte, Recreation Director is preparing for the opening of summer camp registration for the year 2022. This year's Memorial Day parade planning is under way. There are several more activities that are in progress: yoga, pickleball, softball, and soccer. For Information Technology, Councilman DeBlasio was in contact with Phil Scaglione. Mr. Scaglione stated the update of the Borough's computers has been completed and he is working with the County so that the systems are compatible. The cameras, except for (2) in the Police Department, are functioning and recording. A discussion between Wendy Martin, Borough Administrator/Clerk and Councilman DeBlasio occurred regarding the future project of the recording system in the Borough and the Social Hall. Municipal Alliance reports will be the next meeting in April.

ADMINISTRATOR'S REPORT:

Borough Administrator/Clerk Martin updated Mayor and Council concerning the 5G future project. Ms. Martin sent out an email with several open questions, but no final answers have been received. The new electronic voting machines will be used as of 2023. 2022 elections will be a hybrid of old and new electronic machines. Ms. Martin continues to advertise the March 8, 2022 Special School Election via eblast, posts on the Borough's website and posting on the Borough's bulletin board. The cost of this election, with the Borough's involvement, will not be available until after the election. An eblast also went out the subscriber concerning the Ridgewood Water project.

ORDINANCE ON FINAL: 1. ORDINANCE # 02-2022 AN ORDINANCE TO AMEND CHAPTER 9 OF THE CODE OF THE BOROUGH OF MIDLAND PARK ENTITLED, "RECREATIONAL FACILITIES". - TENNIS

BE IT ORDAINED by the Mayor and Council of the Borough of Midland Park, in the County of Bergen, and State of New Jersey as follows:

Section 1.

Chapter 9 of the Code of the Borough of Midland Park, Recreational Facilities, §9-2, Tennis Courts, be and is hereby amended to read as follows:

§9-2.1 Classes of Courts Designated.

The Borough hereby establishes two (2) classes of tennis courts known as "A"- College Road, and "B" – Dairy Street The A tennis courts, which were constructed by municipal funds, shall be located at the Dairy Street Recreation Area (College Road site); and the B tennis courts, which were constructed by municipal, Federal, or State funds, shall be located at the Dairy Street Recreation Area (site B). If additional courts are constructed in the Borough, they shall receive the appropriate designation.

§9-2.2 Card Required; Daily Passes.

§9-2.3 Schedule of Fees.

§9-2.4 Use of Courts by Residents and Nonresidents.

The tennis courts, categorized as A in §9-2.1, are solely for the use of residents of the Borough. A resident of the Borough, when playing, may invite one (1) non-resident guest. The officers of the Police Department of the Borough and other authorized personnel of the Borough may demand at any time proof of such residency as condition precedent to the use of the aforesaid tennis courts by any person or persons. The tennis courts, categorized as B in §9-2.1, may be used by residents and nonresidents. A first-come, first-served basis is a service policy whereby the requests of residents and/or non-residents are attended to in the order that they arrived, without other considerations or preferences. All of the rules and regulations provided herein shall apply to a nonresident as well as a resident.

§9-2.5 Rules for Use of Courts.

1. All persons and guests using the tennis courts in the Borough shall adhere to the rules and regulations set forth hereafter and such additional rules and regulations adopted by the Mayor and Council, which shall govern the use of such facilities. A copy of such rules and regulations shall be posted on a fence at each tennis court location.

2. A first come, first served basis is a service policy whereby the request of resident and/or non-residents, are attended to in the order that they arrived, without other considerations or preferences. All of the rules and regulations provided herein shall apply to a non-resident as well as a resident.

3. Privately paid instructed lessons are prohibited on Borough tennis courts at all times.

4. No person shall use any of the tennis courts unless such person complies in full with the rules and regulations pertaining to the same, as hereinafter set forth.

5. All players must be properly attired, including shirts and tennis shoes or sneakers.

6. Playing time on any court for any player or players is limited to one (1) hour of play, whether playing singles or doubles. However, if, at the termination of such hour, there are no other players waiting to have the court, the players may continue to play past the one-hour time limit and until such time as other players are ready to use the court.

7. At the discretion of the Recreation Board and Department, certain periods on specified courts may be reserved for particular groups or activities based upon rules and regulations developed by the Recreation Board and Department and approved by the Mayor and Council.

8. There may be no litter, undue noise, or use of profanity while on the tennis courts.

9. Courts are for tennis only. Any other use of tennis courts will not be permitted.

10. Defacing or damaging the courts in any way is prohibited.

§9-2.6 Fines and Penalties.

Any person convicted of violating this section shall be subject to such fines or penalties as established in the General Penalty provision of the Borough Code, Section 1-5.

Section 2. Severability. If any section, sentence, or any other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not effect, impair, or invalidate the remainder of this Ordinance but shall be confined in its effect to the section, sentence or other part of this Ordinance directly involved in the controversy which such judgment shall be rendered.

Section 3. Inconsistent Ordinances Repealed.

All ordinances or parts or ordinances which are inconsistent with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistencies.

Section 4. Effective Date.

This Ordinance shall take effect immediately upon final passage and publication as provided by law.
