**Mayor Shortway** reported on April 11, 2022, the Mayor and Borough Administrator/Clerk Wendy Martin attended a meeting in Hackensack, NJ on the subject of OPRA. The **Mayor** was present at the Board of Education meeting on April 13, 2022 and was joined by **Council President Peet** and **Councilwoman DeLuca**.

# **Public Safety – Fire/Ambulance/Library**

Councilwoman DeLuca announced the Ambulance Corps meeting was held on Monday, April 4, 2022. The Councilwoman reported from the Captain's report for the month of March 2022, a total of 69 calls with 540 miles were completed by the Borough's two rigs. The annual Coin Toss will commence on May 14, 2022. Congratulations to the Ambulance Corps for their 80<sup>th</sup> Anniversary in Midland Park. The **Fire Department's** meeting occurred on April 13, 2022. There were 10 calls and 1 assist to Waldwick in the month of March 2022. A wetdown celebrating the new Engine 532 will commence on June 4, 2022. All are invited. The **Library Board's** meeting will be held on Tuesday, April 19, 2022. Please check their website for the listing of activities. The Friends of the Library announced their new slate of officers. The annual Summer Lawn Series will take place on the Borough lawn in the month of July, weather permitting. The **Councilwoman** attended Ramadan service on Wednesday, April 13, 2022. The Mosque generously donated \$1,000.00 to each the Fire Department and the Ambulance Corps.

# Council President Peet Board of Health/ Board of Education/Ridgewood Water

Council President Peet attended the Ramadan celebration with the Mayor and Councilwoman DeLuca this past week. The Council President also attended the JIF recognition meeting with Borough Administrator Wendy Martin to receive \$750.00 and an award for Midland Park's excellent safety status. Ms. Peet also had the opportunity to meet with the Superintendent, Business Administrator, and the Board of Education to discuss the District's usage of the fields in Midland Park. It was decided that the Borough uses the Sunset fields the most. The referendum that was voted down in March 2022 concerning the school's fields will not be ready for a new vote for at least a year. A discussion ensued regarding the Borough purchasing the Upper and Lower Sunset fields. The Board of Education will discuss this idea at their next meeting. The Ridgewood Water reports progress. The Board of Health's Commission's meeting is scheduled for the next quarter. The Borough will hold the Rabies Clinic in May and Borough Administrator/Clerk Wendy Martin has reconfigured the path for cars since last year.

# Councilman DeBlasio Recreation/Information Technology/Municipal Alliance

The **Municipal Alliance** had a scheduled meeting on April 6, 2022. The **Councilman** was unable to attend virtually. The Board of **Recreation**'s meeting could not occur due to an inability to form a quorum. Kathy Lamonte told **Councilman DeBlasio** that softball, yoga, and camp registration is going well. Ms. LaMonte also sent a Letter of Intent for the Open Space Grant on April 8, 2022. For **Information Technology, Councilman DeBlasio** had a meeting with Phil Scaglione. Even though Mr. Scaglione was on vacation for the past week, he was always available to the Borough staff. The **Councilman** also reported the criminals are attacking search engines. The more usage of different engines Midland Park uses, the more chances there are for attacks.

## Councilman Damiano Finance/Public Works/Chamber of Commerce

Councilman Damiano reported progress for Finance. Matthew Tauber, Superintendent of Department of Public Works informed the Councilman of the 2021 Road Resurfing Project streets and areas that are currently being conducted. The spring cleanup on all Borough properties have been completed. The DPW has replaced the water line to the snack bar since it has experienced numerous leaks and other issues. The Chamber of Commerce will notice the Councilman of their next meeting. The Economic Development committee postponed their scheduled meeting.

# Councilman Iannone Public Safety – Police/Property Maintenance/Personnel

**Councilman Iannone** reported the **Police Department** had a total of 212 calls, the majority of them were public service. The total number of motor vehicle summons were 71 for the month of March 2022. The **Councilman** noted **Property Maintenance** had 2 issues at a gas station and another on Spruce Street. Progress was reported for **Personnel.** 

# Councilman Kruis Planning Board/Building Dept/Fire Prevention/OEM

Councilman Kruis reported the **Planning Board** has a scheduled meeting on Monday, April 20, 2022. The **Building Department** reports a volume of building permits and other applications are extremely high. The **Councilman** also met with Michael Rau, **Fire Prevention/OEM** stating he will continue with fire inspections for residential homes and commercial businesses. The Borough received \$5,707.54 reimbursement from FEMA with a total of \$67,010.65 submitted. Also, through the CARES Act, \$158,968.00 was submitted and \$141,532.00 has been received by Midland Park.

#### **ADMINISTRATOR'S REPORT:**

Borough Administrator/Clerk Martin updated the **Mayor** and **Council** that Zoning Board Secretary Jessica Harmon stated applicant City View Residences, where the Sharp Shop is located, has withdrawn their application. Ms. Martin reminded the Mayor and Council to complete their annual Financial Disclosure Statements. They are available online. Sue Hartman from the Municipal Alliance will be applying for a grant and needs the Borough to fill out the necessary paperwork required by the State. Ms. Martin also stated the progress on the upcoming 5G and the electric charging station ordinances. In the next couple of months, these two ordinances will be introduced.

## Section 1.

Chapter VII of the Code of the Borough of Midland Park, Traffic, §7-3.5, Parking Prohibited During Certain Hours On Certain Streets, be and is hereby amended to read as follows:

# **Resolution #072-2022 Recycling Enhancement**

**WHEREAS**, The Recycling Enhancement Act, P.L. 2007, chapter 311, has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

**WHEREAS**, there is levied upon the owner or operator of every solid waste facility (with certain exceptions) a recycling tax of \$3.00 per ton on all solid waste accepted for disposal or transfer at the solid waste facility.

**WHEREAS**, a municipality operates a municipal service system for solid waste collection or provides for regular solid waste collection service under a contract awarded pursuant to the "Local Public Contracts Law", the amount of grant monies received by the municipality shall not be less than the annual amount of recycling tax paid by the municipality, except that all grant moneys received by the municipality shall be expended only for its recycling program.

**NOW, THEREFORE, BE IT RESOLVED,** that the Council of the Borough of Midland Park hereby certifies a submission of expenditure for taxes paid pursuant to P.L. 2007, chapter 311, in 2021 in the amount of \$8,468.07. Documentation supporting this submission is attached and available at the Borough Hall, 280 Godwin Avenue, Midland Park, N. J. 07432, and shall be maintained for no less than five years from this date.

### Resolution #073-2022 Tonnage Grant

WHEREAS, the Mandatory Source Separation and Recycling Act. P.L.1987, c.102, has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

**WHEREAS**, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection has promulgated recycling regulations to Implement the Mandatory Source Separation and Recycling Act; and

**WHEREAS**, the recycling regulations impose on municipalities certain requirements as a condition to applying for tonnage grants, including but not limited to, making, and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

**WHEREAS**, a resolution authorizing this municipality to apply for such tonnage grants for the year 2022 will memorialize the commitment of this municipality to recycling and to indicate the assent of The Mayor and Council of the Borough of Midland Park to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

**WHEREAS**, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Borough of Midland Park that the Borough of Midland Park hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates Bergen County Utilities Authority, Recycling Coordinator, to ensure that the application is properly filed; and

**BE IT FURTHER RESOLVED** that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.

# Resolution #074-2022 Purchase of Dairy Street Playground Equipment

**WHEREAS**, the Borough of Midland Park wishes to replace the Dairy St. playground with new equipment from an authorized vendor using Bid #ESCNJ 20-21/22; Co-Op #65MCESCCPS; and

**WHEREAS**, the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, N.J.S.A. 40A:11-12; and

**WHEREAS**, the DPW Superintendent has recommended the utilization of this bid on the grounds that represents the best price available; and

**WHEREAS**, the actual cost for the purchase of various new playground equipment is \$157,612.64 from Ben Shaffer Recreation Inc., P.O. Box 844, Lake Hopatcong, NJ 07849;

WHEREAS, the Chief Financial Officer has certified the availability of funds for this purchase,

**NOW THEREFORE, BE IT FURTHER RESOLVED**, by the Council of the Borough of Midland Park that a purchase of various playground equipment is authorized from the above mentioned dealership.

# Resolution #075-2022 Urging Swift Passage of S-330/A3804 Restore Energy Tax Receipts to Municipalities

WHEREAS, taxes on gas and electric utilities were originally collected by the host municipalities to be used for local purposes and to compensate the public for the use of their rights of way; and

**WHEREAS**, when the State made itself the collection agent for these taxes, it promised to dedicate the proceeds to municipal property tax relief; since, just as municipalities collect property taxes for the benefit of school districts, counties, and other entities, the State is supposed to collect Energy Taxes for the benefit of municipal governments; and

**WHEREAS**, for years, though, State budget makers have diverted funding from Energy Taxes to fund State programs; and instead of being spent on local programs and services and used to offset property taxes, the money has been spent as successive Legislatures and Administrations have seen fit; and

WHEREAS, the diversion of dedicated energy tax receipts to the State's General Fund further jeopardizes this critical property tax relief funding in future years; and

**WHEREAS**, by reducing Consolidated Municipal Property Tax Relief Act (CMPTRA), which is also comprised of revenues that should be returned to municipalities, State Budget makers have been able to continue collecting Energy Taxes, while keeping additional revenue that should have been returned to provide property tax relief; and

WHEREAS, the cumulative impact of years of underfunding has left many municipalities with serious needs and burdensome property taxes; and

**WHEREAS**, local elected officials are in the best position to decide the best use of these resources, which were always intended to fund local programs and services; and

**WHEREAS**, Senator Singleton and Senate President Scutari have introduced legislation (S-330) that will restore, over a five-year period, Energy Tax Receipts to municipalities;

**NOW, THEREFORE, BE IT RESOLVED,** that the Mayor and Council of the Borough of Midland Park in the County of Bergen urges the Legislature to swiftly pass this legislation and Governor Murphy sign the legislation prior to passage of the FY2023 State budget; and

**BE IT FURTHER RESOLVED,** that a copy of this Resolution is forwarded to Senate President Scutari, Assembly Speaker Coughlin, Governor Murphy, and the League of Municipalities.

Resolution #076-2022 Support of the Ability of Municipalities to Adopt Regulations to Protect Public Health, Safety and Welfare from Threats of Flooding

**WHEREAS**, in recent years, residents have experienced more frequent and severe storms, which have caused increased flooding and flood damage in the municipality; and

**WHEREAS**, the increase of flooding events and flood damage threatens the public health, safety, and welfare, imposes economic damages to residents, and taxes municipal services that are forced to respond to increased flooding; and

**WHEREAS**, pursuant to N.J.A.C. 7:8-1.5(a), municipalities are permitted to impose additional or more stringent stormwater management requirements than the model ordinance promulgated by the New Jersey Department of Environmental Protection ("NJDEP"); and

WHEREAS, each municipality has unique situations that may require additional or more stringent regulations in order to be in full compliance with the controlling state and federal statutes, regulations, and permits, and in order to protect their residents from threats of flooding and flooding related damage; and

WHEREAS, the New Jersey Department of Community Affairs ("NJDCA") is considering proposed regulations amending Residential Site Improvement Standards that would further curtail a municipality's ability to protect its residents from the threat of flooding and flood related damage; and

**NOW THEREFORE, BE IT RESOLVED** by the governing body of Borough of Midland Park that it supports regulations that provide flexibility to municipalities to adopt additional and/or more stringent stormwater regulations, in order to allow municipalities to protect its residents from threats of flooding and flood damage; and
