Mr. Papapietro asked how does it compare to last year? Members of the Council stated it is around the same amount as last year. Mr. Papapietro stated that given the loss of revenue due to COVID-19, the Council did a great job keeping the number as low as they did.

# **LIAISON REPORTS:**

#### **Mayor Shortway**

**Mayor Shortway** reported he attended the May 8<sup>th</sup> Mayors' breakfast: the guest speaker was Karen Randall, wife of the Ho-Ho-Kus Mayor, spoke of the cyber-attack of May 6<sup>th</sup> which involved the Colonial Pipeline. He and **Councilwoman DeLuca** attended the National Day of Prayer service on May 6<sup>th</sup>; he attended the holiday service at the mosque with **Councilwoman Peet**; he spoke to Tom Connolly of Bergen County Roads and the approval for the Godwin Avenue project is scheduled for this fall with the work planned to begin in the spring of 2022.

# Councilwoman Peet Board of Health/ Board of Education/Municipal Alliance

Councilwoman Peet reported the Board of Health held the annual rabies clinic on May 10<sup>th:</sup> it was a drive-through and very successful with over 100 participants; she thanked the Citizens Emergency Response Team for their help, the Police Department, the office staff, the North West Bergen Regional Health Commission members and Board of Health participants and especially Acting Administrator/Borough Clerk Martin for all the effort she put into setting it up to make it work so well. The Councilwoman noted Midland Park is ahead of the State norm for COVID-19 vaccinations with 56% of adults fully vaccinated and 70% of adults with one dose. She noted that before the service at the mosque, there was a vaccine clinic. Councilwoman Peet reported school attendance is back to in-person five days per week and they are observing three foot distancing.

**Councilwoman Peet** reported she attended the **Board of Education** meeting on May 4<sup>th</sup> where the budget was presented: the discretionary funds portion totaled \$1.5 million dollars of budget; the proposed amount for the 2021-2022 general fund is \$24,986,728 which is an increase of 2.4%; the debt service amount comes to \$939,125 which is a .18% increase; the total tax levy is \$22,455,969 for a 2.54% increase; the total impact equals \$189/year. For further details, please visit the Board of Education website. The **Councilwoman** stated the Board of Education liaisons are looking forward to the May 25<sup>th</sup> liaison meeting.

Councilwoman Peet noted there was no report for the Municipal Alliance at this time.

# Councilwoman DeLuca Public Safety – Fire/Ambulance/Library

**Councilwoman DeLuca** reported she attended the **Ambulance Corps** meeting on May 3<sup>rd</sup>: they answered 58 calls for service in May with one mutual aid in because both rigs were in service; the new ambulance has arrived, and members are continuing to receive training on it.

**Councilwoman DeLuca** reported she attended the May 12<sup>th</sup> **Fire Department** meeting: they responded to 12 calls in May; the annual Memorial service will be held on Wednesday, May 26<sup>th</sup> at 7:30pm and all are invited to attend.

**Councilwoman DeLuca** reported **the Library Board** will be holding their meeting the 18<sup>th</sup> and she will give the report at next Council meeting; the Library is having a town "Scavenger Hunt" to coincide with the Summer Reading program; the clues are animal tails in green and will be distributed throughout the town; the Director has contacted businesses in town as to placing clues and securing funds for prizes. The **Councilwoman** asked the Council for permission for a clue to

be placed at Borough Hall? The consensus was Yes. For more information on the various programs the Library sponsors, please visit their website.

Councilman Damiano Finance/Recreation/Information Technology

Councilman Damiano reported he attended the May 3<sup>rd</sup> Board of Recreation meeting: there is interest in starting an adult Kickball league, which would use Veterans' field or Vander Meer field and the Recreation Director would block off a certain day and time for them, and an adult Cornhole league; the Recreation Director checked with the insurance company and it would cost about \$273 to cover for accidents; if the Council agrees to the expense, she can set it up; the Pickleball league has inquired about using an outside space, preferably one of the tennis courts or one of the basketball courts; it would require additional lining and the town ordinance states: Basketball use only unless otherwise authorized by Mayor and Council. This will be discussed in the upcoming Closed Session. The Councilman noted May 22<sup>nd</sup> is set for Beautification Day: the Cub Scouts will be cleaning up litter at Wortendyk and Bank Street, the Boy Scouts will be spreading mulch at the Veterans of Foreign Wars building, the Daisies will be cleaning up and planting at the Highland School. Councilman Damiano gave a status report on summer camp: if COVID restrictions lift significantly on May 19<sup>th</sup>, the Recreation Director stated she would like to open registration to Waldwick residents on May 24<sup>th</sup> without raising rates.

Council President Iannone Public Safety – Police/ Personnel/Ridgewood Water Due to Council President Iannone's absence, no report was given.

**Councilman Kruis** reported the **Fire Prevention Official** has completed 23 inspections, 2 reinspections, and all educational facilities are in the process of being done and should be completed by June 1<sup>st</sup>.

The Councilman reported the Office of Emergency Management Official has submitted and the Borough has received COVID-19 reimbursements totaling \$154,040.36.

# Public Works/Chamber of Commerce/Economic Development Committee

Councilman Sansone reported the Department of Public Works has been busy: they completed the project on the batting cages; it was a collaboration between Baseball, Softball and the DPW; they continue to disinfect all police cars and borough buildings for COVID; the Superintendent has been in contact with restaurants that have applied for tents for dining areas and have placed barriers to protect those areas from traffic.

**Councilman Sansone** reported the **Economic Development Committee** will be meeting on May 20<sup>th</sup> and there is progress.

The Councilman reported progress for the Chamber of Commerce.

#### ADMINISTRATOR'S REPORT

Acting Administrator Martin reported the Property Maintenance Official has been working closely with residents and staying on top of any issues; the Borough has received the JIF payment of \$1000.

# **ORDINANCES ON FINAL:**

#### 1. ORDINANCE #07-21

"AN ORDINANCE BY THE BOROUGH OF MIDLAND PARK IN THE COUNTY OF BERGEN, NEW JERSEY PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESSES WITHIN ITS GEOGRAPHICAL BOUNDARIES AND AMENDING SECTION 34-1.4, PROHIBITED USES IN ALL ZONES, OF THE BOROUGH CODE"

**WHEREAS**, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

**WHEREAS**, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from one licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for
  consumer purchases that are fulfilled by a licensed cannabis retailer in order to make
  deliveries of the purchased items to a consumer, and which service would include the
  ability of a consumer to make a purchase directly through the cannabis delivery
  service which would be presented by the delivery service for fulfillment by a retailer
  and then delivered to a consumer.

WHEREAS, Section 31a of the Act authorizes municipalities by Ordinance to adopt regulations governing the number of cannabis establishments (defined in Section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location, manner and times operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

**WHEREAS**, Section 31b of the Act authorizes municipalities by Ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services

anywhere in the municipality; and

**WHEREAS**, Section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (*i.e.*, by August 22, 2021); and

**WHEREAS**, pursuant to Section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

**WHEREAS**, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such Ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Mayor and Council of the Borough of Midland Park has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Borough of Midland Park in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of the Borough's residents and members of the public who visit, travel, or conduct business in the Borough of Midland Park, to amend the Borough of Midland Park's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of the Borough of Midland Park; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

**NOW THEREFORE, BE IT ORDAINED,** by the Mayor and Council of the Borough of Midland Park, in the County of Bergen, State of New Jersey, as follows:

- 1. Pursuant to Section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Borough of Midland Park, except for the delivery of cannabis items and related supplies by a delivery service.
- 2. Chpater 34 of the Borough Code, Zoning, Section 34-1, General Provisions, Subsection 34-4.1, Prohibited Uses In All Zones, is hereby amended to read as follows: "In every Zoning District referred to in Section 34-2 of this Chapter, no land or building shall be used or allowed to be used for any class of cannabis establishment, cannabis distributor or retailer, or cannabis delivery service as said terms are defined in Section 3 of P.L. 2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery service."

- 3. Any person found guilty of violating the provisions of this Ordinance shall be subject to such fines and penalties as set forth in Section 1-5 of the Borough Code.
- 4. Any article, section, paragraph, subsection, clause, or other provision of the Midland Park Borough Code inconsistent with the provisions of this Ordinance is hereby repealed to the extent of such inconsistency.
- 5. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this Ordinance shall be deemed valid and effective.
- 6. This Ordinance shall take effect upon its passage and publication and filing with the Bergen County Planning Board, and as otherwise provided for by law.

Councilman Sansone asked Attorney Regan to explain why the Council has passed this ordinance. Attorney Regan stated the Council has 180 days to pass an ordinance prohibiting one or more classes of cannabis. If the Council did not act by August 22, 2021, it would be precluded from any action for five years. Since this ordinance has passed, the Council can now do research as to the benefits and detriments the different classes of cannabis can be and they can pass new ordinances allowing cannabis classes during those five years.

# Resolution #098-21 Borough of Midland Park and DiGenova Family- 10 Franklin Avenue Blk $7.02\ Lt\ 1.05$

WHEREAS, there presently exists on property owned by Nicholas Di Genova and Stephanie Di Genova ("the Property Owners") located at the corner of Franklin Avenue and Maltbie Avenue, known as Block 7.02, Lot 1.05, being more commonly known as 10 Franklin Avenue ("the property"), an existing fence, together with a portion of an existing patio and walkway, located on the Maltbie Avenue side of the property within the Borough right-of-way and located twelve (12) inches from the curb within said roadway; and

WHEREAS, the Property Owners desire to replace this fence with a new fence to be located

within the Borough right-of-way which would be located approximately six (6) feet from the back of the curb, with the existing patio and walkway to remain; and

**WHEREAS,** as a result of the proposed intrusion of the fence into the Borough right-of-way area, and the continued maintenance of a portion of the existing patio and walkway thereon, approval of the Mayor and Council is required.

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Midland Park that permission is hereby granted to the Property Owners to replace the existing fence with a new fence located approximately, six (6) feet from back of the curb, and the continued maintenance of the existing patio and walkway in the Borough right-of-way, subject to the following conditions:

- 1. Execution of a "Hold Harmless Agreement" by the Property Owners, which shall provide that should the Borough require access to the area of the right-of-way for any reason, the Borough shall have the right to remove the fence and the portion of the patio and walkway or take such action as it deems necessary, in its sole and exclusive discretion, to access the right-of-way area.
- 2. The location, size and dimensions of the fence shall be in accordance with a survey of the property prepared by Schmidt Surveying dated March 15, 2021 which depicts the proposed fence location, as well as the existing fence, which is to be removed, together with a portion of an existing patio and walkway.
- 3. Compliance with all requirements of the Borough Engineer, Zoning Officer and Construction Official.
- 4. Payment of all required fees, including reimbursement of Borough professionals for services in this matter and costs incurred for recording the "Hold Harmless Agreement".

# Section 1.

#### 4. ORDINANCE #12-21

# "AN ORDINANCE TO AMEND CHAPTER 3 OF THE CODE OF THE BOROUGH OF MIDLAND PARK ENTITLED, "POLICE REGULATIONS" (CANNABIS)

**BE IT ORDAINED** by the Mayor and Council of the Borough of Midland Park, in the County of Bergen, and State of New Jersey as follows:

# Section 1.

Chapter 3 of the Code of the Borough of Midland Park, Police Regulations, §3-16, be and is hereby amended to read as provided, together with Subsections thereafter:

#### §3-16. Prohibition of All Cannabis Establishments.

#### §3-16.1. All Classes of Cannabis Prohibited.

Pursuant to Section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Borough of Midland Park, except for the delivery of cannabis items and related supplies by a delivery service.

#### §3-16.2. Fines and Penalties.

Any person found guilty of violating the provisions of this Ordinance shall be subject to such fines and penalties as set forth in Section 1-5 of the Borough Code.

#### Section 2. Severability.

If any section, sentence or any other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not effect, impair, or invalidate the remainder of this Ordinance but shall be confined in its effect to the section, sentence or other part of this Ordinance directly involved in the controversy which such judgment shall be rendered.

# Section 3. Inconsistent Ordinances Repealed.

All ordinances or parts or ordinances which are inconsistent with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistencies.

# **Section 4. Effective Date.**

This Ordinance shall take effect immediately upon final passage and publication as provided by law.
