### **OPEN TO THE PUBLIC:**

Mayor Shortway opened the meeting to the public for general questions, concerns, and comments. There being no one from the Public, the Public Portion was closed.

### **LIAISON REPORTS:**

Mayor Shortway

Mayor Shortway stated on February 2, 2023, the Mayor attended a seminar at the Senior Center along with Councilwoman Peet. Congressman Josh Gottheimer lead the discussion of scams that target seniors.

Councilman Braunius Office of Emergency Management/ Recreation/Chambers of Commerce Councilman Braunius reported there is progress for the Office of Emergency Management. Kathy LaMonte, Director of the Department of Recreation has implemented a program for honoring veterans with flag banners throughout Midland Park. Applications for this program will be accepted until May 8, 2023. Another event being established by the Department of Recreation will be an open house for new residents to introduce them to Midland Park and provide useful information from the Borough's departments and the Chambers of Commerce. A welcome packet is being compiled.

Councilman DeBlasio Information Technology/Building Department/Municipal Alliance Councilman DeBlasio reported there has been progress with the Municipal Alliance. The Councilman will be touring the Building Department in the near future with Building Official Mark Berninger. A full report will follow. Information Technology Philip Scaglione has semi-completed the testing and rerunning wires for the security cameras at the Recreation Center. A meeting with Police Chief Michael Powderley, Superintendent of Public works Matthew Tauber, Information Technology Philip Scaglione, and Director of Recreation Kathy LaMonte will occur in the next few weeks to discuss cameras and security for the Borough's fields and the Recreation Center.

Councilman Damiano Finance/Public Safety – Ambulance/Fire Prevention Councilman Damiano was absent. Councilman Braunius stated the Borough's Bills List has been completed.

Councilman Kruis stated there was progress reported for Property Maintenance. Superintendent of Public Works Matthew Tauber informed the Councilman about projects: fire alarm system at the firehouse, Department of Public Works, and the Social Hall is almost completed, the fire house roof is almost completed as well, the generator at the Library is in the final stages, and DPW is waiting for the manufacturer for the shipment of the bay window. The Borough's salt allocations are at a high level due to the lack of snowfall this season. Mr. Tauber is involved with many more projects and will inform the

Councilman as they occur. The Planning Board has not met yet in the month of February 2023.

Councilwoman Peet Public Safety – Police/Board of Health/Bd of Education/Ridgewood Water Councilwoman Peet informed the Governing Body of the monthly report statistics from the Police Department responded to 233 public service calls which included community service and assisting residents. The Board of Health and the NorthWest Regional Health Commission will be providing the Borough with a monthly report of activity to be published on Midland Park's website. The Commission began the 2023 annual inspections and renewal of the licensed businesses in the Borough. The meeting of the Board of Education was to be held on February 7, 2023 meeting. The Councilwoman announced Track and Field received an anonymous donation for purchasing equipment. Other motions were made at the meeting and approved. Councilwoman Peet asked Director Richard Calbi of Ridgewood Water for an update on the lead line project. Mr. Calbi is waiting for the other communities to respond to outstanding issues.

# **Council President DeLuca**

Public Safety - Fire/Personnel/Library

Council President DeLuca stated she attended the Fire Department's meeting on February 8, 2023. The total number of calls for January 2023 was 17 and a mutual aid request to North Haledon. The devastating fire at 222 Franklin Avenue was reviewed at the meeting. The Library Board's meeting will be conducted on February 21, 2023. Library Director Catherine Dileo updated the Council President on the installation of the generator. The Eagle Scouts project to scan the yearbooks will begin shortly.

# **ADMINISTRATOR'S REPORT:**

Borough Administrator/Clerk Wendy Martin reported the NorthWest Regional Health Commission provided the Office of Emergency Management with a supply of free at home COVID-19 tests. The tests will be distributed to the Borough's employees and the Ambulance Corps.

### **ORDINANCES ON FINAL:**

1. ORDINANCE #01-2023

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET COST OF LIVING ALLOWANCE AND TO ESTABLISH A CAP BANK WHEN THE COST OF LIVING ADJUSTMENT (COLA) IS EQUAL TO OR LESS THAN 2.5 PERCENT (N.J.S.A. 40A: 4-45.14)

**BE IT ORDAINED,** by the Borough Council of the Borough of Midland Park, in the County of Bergen, New Jersey, as follows:

WHEREAS, the Local Government Cap Law, N.J.S.A 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% or the Cost-of-Living Adjustment (COLA), whichever is less, over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:45.14 provides that a municipality may, in any year in which the COLA is equal to or less than 2.5% increase its final appropriations by a percentage greater than the COLA, but not to exceed the 3.5% rate as specified in the law, when authorized by ordinance; and,

WHEREAS, the COLA for CY 2023 has been certified by the Director of the Division of Local Government Services in the Department of Community Affairs as 2.5%; and,

WHEREAS, N.J.S.A 40A:4-45.15a provides that a municipality may, in any year in which the COLA is equal to or less than 2.5% may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Midland Park, in the County of Bergen, finds it advisable and necessary to increase its CY 2023 Budget by up to 3.5% over the previous year's final

appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$314,648.53 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Midland Park, in the County of Bergen, a majority of the full authorized membership of this governing Body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the Borough of Midland Park shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$9,304,606.61 and that the CY 2023 municipal budget for the Borough of Midland Park, be approved and adopted in accordance with this ordinance; and

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED,** that a certified copy of this ordinance as Introduced be filed with the Director of the Division of Local Government Services within 5 days of Introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon Adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such Adoption.

**BE IT FURTHER ORDAINED,** that any ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance, are hereby repealed, but only to the extent of such inconsistencies.

This ordinance shall take effect at the time and in the manner provided by law.

The Property Maintenance Official will also be responsible for the enforcement of the following codes: Chapter 14-2 titled; "Removal of Impediments", and Zoning Ordinance §34-13.5, titled; "Trailers, Mobile Homes, Boats, Campers, and Wheel Based Vehicles", and §15-3.3 "Yard Waste Collection", and §15-3.4 "Enforcement".

2. ORDINANCE #05-2023

"AN ORDINANCE FOR THE VACATION OF HOMER AVENUE SITUATE IN THE BOROUGH OF MIDLAND PARK, COUNTY OF BERGEN, STATE OF NEW JERSEY"

**BE IT ORDAINED** by the Mayor and Council of the Borough of Midland Park, County of Bergen, and State of New Jersey, as follows:

WHEREAS, by a certain map bearing date April 1871, entitled "Property of Edward H. Babcock, Wortendyke, Bergen County, New Jersey, scale 100 feet per inch. F. Watlington, Surveyor, dated April 1874 and filed in the Bergen County Clerk's Office on August 27, 1902, filed map #876, there appears a certain street thereon known as Homer Avenue; and

WHEREAS, it appears to the Borough Council of the Borough of Midland Park that said street is not needed for public use; that the public interest will be better served by releasing said lands as hereinafter more particularly described from the effect of any such dedication which many have been made by the aforesaid map, and in order to avoid any future question respecting the dedication of said street;

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Midland Park in the County of Bergen as follows:

<u>Section 1.</u> That the following described land and premises situate lying and being in the Borough of Midland Park, County of Bergen and State of New Jersey, be and the same are hereby vacated, viz:

BEGINNING at the point of intersection of the northeasterly line of Meda Place with the northwesterly line of Homer Avenue, said point being also the southeasterly corner of Lot 1 in Block 44-B on the current Tax Map of the Borough of Midland Park: thence from said point of beginning running:

    - (1) Service/panels/subpanels to 400 ampere: \$250.
    - (m) Service/panels/subpanels to 800 ampere: \$300.
    - (n) Service/panels/subpanels to 1,000 ampere and higher: \$450.
    - (o) HVAC and central AC, per unit: \$75.
    - (o) Solar Batteries to 10 kilowatts: \$75.
    - (p) Solar Batteries to 45 kilowatts: \$125.
    - (g) Solar Batteries to 112.5 kilowatts: \$175.00
    - (r) Solar Batteries above 112.5 kilowatts: \$225.
