**7:00 P.M. WORK SESSION MINUTES**

**On March 10, 2022 at 7:00 P.M., the Mayor and Council of the Borough of Midland Park conducted a meeting at Borough Hall located at 280 Godwin Avenue as previously advertised. **Mayor Shortway** called the Meeting to Order at 7:00 P.M.

**DISCUSSION ITEM:**

**1. 2022 Open Space Grant – Project Ideas**

Borough Administrator/Clerk Martin recapped **Council President Peet's** request for "seven on seven" playing fields from the previous Mayor and Council Meeting on February 24, 2022. Kathy LaMonte, Recreation Director researched the needs of the Borough's soccer teams and conveyed to Borough Administrator/Clerk Martin that the older children need practice and playing fields, not the younger age group. Ms. Martin will request the Soccer Association to attend the next Mayor and Council Meeting for their recommendations. Ms. Martin also stated the Letter of Intent must be sent to the State for the 2022 Open Space Grant by the beginning of April 2022.

**Council President Peet** suggested that the Woodside Avenue property be used as a practice soccer field. The **Council President** understands that parking is limited, and that the Borough does not want to infringe upon the residents of the street with unwanted traffic.

**Resolution #051-2022 Closed Session 03-10-2022**

**WHEREAS**, N.J.S.A. 10:4-12 allows for a Public Body to go into closed session during a Public Meeting; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Borough Council of Midland Park will go into closed session for the following reason (s) as outlined in N.J.S.A. 10:4-12:

- \_\_\_\_\_ Any matter which, by express provision of Federal Law, State Statute or Rule of Court shall be rendered confidential or excluded from discussion in public (Provision relied upon):
- \_\_\_\_\_ Any matter in which the release of information would impair a right to receive funds from the federal government;
- \_\_\_\_\_ Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy;
- \_\_\_\_\_ Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body (Specify contract): \_\_\_\_\_.
- \_\_\_\_\_ Any matter involving the purpose, lease, or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed;
- \_\_\_\_\_ Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection;
- \_\_\_\_\_ Any investigations of violations or possible violations of the law;
- \_\_\_\_\_ Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. \_\_\_\_\_ Any deliberation of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party as a result of an act of omission for which the responding party bears responsibility;

**BE IT FURTHER RESOLVED**, that the Borough Council hereby declares that its discussion of the aforementioned subject(s) may be made public at a time when the Borough Attorney advises the Borough Council that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the Borough, or any other entity, with respect to said discussion. That time is currently estimated as the time of said matter.

**BE IT FURTHER RESOLVED** that the Borough Council, for the aforementioned reasons, hereby declares that the public is excluded from the portion of the meeting during which the above discussion shall take place, and hereby directs the Borough Clerk to take the appropriate action to effectuate the terms of this resolution.
