7:00 P.M. WORK SESSION MINUTES

On April 14, 2022 at 7:00 P.M., the Mayor and Council of the Borough of Midland Park conducted a meeting at Borough Hall located at 280 Godwin Avenue as previously advertised. Agenda items for the meeting were listed on the Borough website. Mayor Shortway called the Meeting to Order at 7:00 P.M.

DISCUSSION ITEM:

1. Sample Resolutions
 - a. Support of Reforms – Vehicle Pursuit Policy (see attached)
 - b. Support of Bail Reforms (see attached)

Borough Administrator/Clerk Wendy Martin opened the discussion for the two sample resolutions concerning supporting reforms for Vehicle Pursuit Policy and Bail Reforms. Chief Michael Powderly was in full agreement with introducing both resolutions. Mayor and Council agreed.

- c. Reduce or Suspend State Tax on Highway Fuels A3669 (see attached)After a short discussion, Mayor and Council gave their consent for a resolution supporting introduction for the next meeting.
- d. Ukraine Support (see attached)

The Mayor and Council carried the topic of a Ukraine support resolution until a later date.

2. Wortendyke Park – Pavilion & Park

Council President Peet recapped a conversation she had with Michael Kenney, President of the Soccer Association. Mr. Kenney was interested in converting the Wortendyke Park into a turf field

for sporting events. After a discussion with Superintendent of Department of Public Works, Matthew Tauber, the change would not be monetarily feasible. Councilwoman DeLuca stated the park is also used by residents for walking and the Library uses the area for their activities.

Council President Peet was approached by a resident to join or create the Shade Tree Committee. Borough Administrator/Clerk Wendy Martin stated the Shade Tree Committee consists of Matthew Tauber and herself. Ms. Martin stated she will look into surrounding towns' tree ordinances.

Resolution #068-2022 Closed Session 04-14-2022

_____ Any matter which, by express provision of Federal Law, State Statute or Rule of Court shall be rendered confidential or excluded from discussion in public (Provision relied upon):

_____ Any matter in which the release of information would impair a right to receive funds from the federal government;

_____ Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy;

_____ Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body (Specify contract): _____.

_____ Any matter involving the purpose, lease, or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed;

☒ Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection;

_____ Any investigations of violations or possible violations of the law;

_____ Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer (If pending or anticipated litigation, the matter is: _____, contract negotiations the nature of the contract and interested party is _____ in circumstances, if public disclosure of the matter would have a potentially negative impact on the Borough's position in the litigation or negotiation, this information may be withheld until such time that the matter is concluded, or the circumstances no longer present a potential impact);
