**DISCUSSION ITEMS:**

**1. Legends Restaurant and Pub – outdoor dining expansion to the parking lot**

**Administrator Seemon** explained the request for additional outdoor dining in the parking lot of the establishment, noting all departments have reviewed the plan. The difference between other establishments and this one is the parking lot is a public thru way. **Mayor and Council** discussed the outdoor dining options for this establishment. The consensus of the Mayor and Council is to approve the request. This will fall under the temporary outdoor dining permit that the establishment has already applied for and was approved. **Administrator Seemon** also stated the absent Council members, Sansone and Iannone are both in favor.
