Mayor Shortway called the Meeting to Order at 7:00 P.M.

Administrator Seemon - Roll call of the public

No members of the public are present at this time.

DISCUSSION ITEMS:

Community Day – Administrator Seemon advised the Governing Body of the recommendations from the Northwest Bergen Regional Health Commission's Health Official, Gina Marie Behre, stating "their goal from public health is to reduce the possibility of transmission and despite all best efforts, when people congregate it increases the chance of being exposed to SARS-COV-2 virus and subsequent development of COVID-19 disease among participants. The more people an individual interacts with at a gathering and the longer that interaction lasts, the higher the potential risk of becoming infected with COVID-19 and/or COVID-19 spreading. From a public health perspective, when possible, we strongly discourage

the congregating of large groups of people at this time. The majority of other communities already canceled large scaled events such a street fairs in the fall due to current guidelines: including but not limited to outdoor capacity (gatherings are capped at 500 people), the inability to safely social distance, safely monitor cleaning and sanitizing, screening and determine whether the COVID 19 numbers will resurge and/or continue to climb. As much as I would hope the future climate would work in our favor my recommendation is to cancel the community event this fall."

Administrator Seemon and Recreation Director LaMonte are suggesting holding another community Drive-in Movie. The following dates are available to host the event, October 2nd and October 9th, keep in mind October 9th is just before a holiday weekend.

The Mayor and Council agreed Community Day will have to be canceled this year and the Drive-in-Movie is a great alternative.

Councilman Kamp and other members of the Council suggest the event be on October 2nd, as many may go away for the long weekend and we would like this event to be available for the entire community. Both the previous Drive-in Movie evenings were very successful. **Recreation Director LaMonte** will move forward with scheduling and advertising the event. **Recreation Director LaMonte** suggested utilizing the Library parking lot for two food trucks. After a brief discussion with the Governing Body it was decided to reach out to the Health Official to provide us with guidance, at this time the food trucks would not be an option at the event.

Recreation Director LaMonte advised the Governing Body of how much usage the Borough's pavilions have increased. She stated that many of the Boy Scout and Girl Scout troops have booked weekly meetings, two to three a week through November. The Director also stated she will most likely be receiving requests from other organizations as the word gets out.

Recreation Director LaMonte also advised the Governing Body that Football and soccer have started their practices, they sign waivers and have temperature checks at each practice. Councilman Kamp asked if any of the surrounding towns canceled their fall sports programs? The Director stated in the Borough's league, Dumont, Tenafly and New Milford all pulled out of the program.

- Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy;
- Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body (Specify contract):
- Any matter involving the purpose, lease or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed;
