## BOROUGH OF MIDLAND PARK March 25, 2021

7:00 P.M. -Work Session Minutes

On March 25, 2021 at 7:00 p.m., the Mayor and Council of Midland Park conducted an Electronic Public Meeting in lieu of its in-person Public Meeting previously advertised. Members of the public accessed the meeting by dialing this Toll-Free Dial in number 1 866 899 4679 Access Code: 529-715-845

Agenda items for the meeting were listed on the Borough website. The foregoing Electronic Public Meeting was recommended due to the current situation involving the COVID-19 Virus and directives of State and County governments.

Mayor Shortway called the Meeting to Order at 7:00 P.M.

#### **DISCUSSION ITEMS:**

 2021 Budget Discussion- Mark Bednarz, Borough Auditor, Donohue, Gironda, Doria & Tomkins LLC

Council President Iannone welcomed Mark Bednarz, the Borough Auditor, to the meeting to explain details and answer questions from the Council regarding the 2021 Budget. Mr. Bednarz explained the history of how decisions were made in the past to reduce the budget and how it is impacting the current budget. Councilman Sansone took the opportunity do express a suggestion relative an area the Borough could save some money, selling off the Habben Building and putting the proceeds back into our reserves. This is not the first time this has been a item up for recommendation. Acting Borough Administrator/Borough Clerk Martin addressed the topic stating the Administration has actively been relocating the files at that location back to the Borough Hall basement which is being transformed into a file storage area. The majority of the files have been relocated with the exception of the Police files. Those records need to be handled differently. In addition to other specifics related to the Police Department. Once the Police Department specifics is resolved the Habben Building can be addressed. The Borough Auditor stated in order for you to anticipate those funds to offset taxes a contract would have to be in place for adoption otherwise the State will not allow you to anticipate those funds. Attorney Regan stated the building would also have to be publicly advertised for sale and this will not happen for this budget. Councilman Sansone asked if there were any updates relative to the relief funds the government is supposed to be giving local municipalities. Both the Auditor and CFO state there has been no guidance at this point. The only thing clear is the funds can be earmarked for revenue loss. We are waiting on future guidance. The Auditor provided some options on how to move forward with the current budget. Further discussion took place relative to the budget. Acting Administrator/Borough Clerk Martin advised the Council of a future savings under personal in the amount of \$40,000.00 that could be of some help in certain areas. CFO O'Hanlon stated these funds could help offset the library shortage they feel they are receiving, and we can reclass the remainder to another personal salary adjustment or remove the remainder completely. The library would receive the \$455,000.00 they were expecting. CFO reiterated we will introduce the budget as is at the April 8, 2021, meeting and if we get further guidance by April 15, 2021, we can amend the introduced budget before we adopt the budget. If we do not receive anything and we adopt then later something comes from the State in June, for example, I can process a Chapter 159.
