in writing that such matter or matters be discussed at a public meeting (Subject to the balancing of the
public's interest and the employee's privacy rights under South Jersey Publishing, 124 N. J. 478, the
employee(s) and nature of discussion is Personnel: DPW, Public Safety Communications Advisory
Board.
Any deliberation of a public body occurring after a public hearing that may result in the
imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or
permit belonging to the responding party as a result of an act of omission for which the responding party
bears responsibility;
BE IT FURTHER RESOLVED, that the Borough Council hereby declares that its discussion of the
aforementioned subject(s) may be made public at a time when the Borough Attorney advises the Borough
Council that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the
Borough, or any other entity, with respect to said discussion. That time is currently estimated as the time
of said matter.
BE IT FURTHER RESOLVED, that the Borough Council, for the aforementioned reasons, hereby
declares that the public is excluded from the portion of the meeting during which the above discussion shall
take place, and hereby directs the Borough Clerk to take the appropriate action to effectuate the terms of
