#### 7:00 P.M. WORK SESSION MINUTES

On June 22, 2023 at 7:00 P.M., the Mayor and Council of the Borough of Midland Park conducted a meeting at Borough Hall located at 280 Godwin Avenue as previously advertised. Agenda items for the meeting were listed on the Borough website.

### **DISCUSSION ITEM:**

- Sample Resolution Municipal Opposition to NJ Assembly Bill A-4376
   Borough Administrator/Clerk Wendy Martin summarized the description of NJ Assembly Bill A-4376. This Bill is concerning 5G Cell and the conditions for service providers. The Governing Body all agreed to support this Bill to oppose NJ Assembly Bill A-4376.
- 2. Sample Resolution Municipal Support of S-3807 & A-5567 Amending the Local Bond Law Borough Administrator/Clerk Wendy Martin briefly described the Bills S-3807 and A-5567. These Bills are in support of amending fire truck Bond Laws. Borough Attorney Robert Regan stated fire trucks should not exceed a ten-year life span. The Mayor and Council concurred.

employees or representatives of employees of the public body (Specify contract):
Any matter involving the purpose, lease, or acquisition of real property with public funds, the setting
of bank rates or investment of public funds where it could adversely affect the public interest if discussion
of such matters were disclosed;
XAny tactics and techniques utilized in protecting the safety and property of the public provided that
their disclosure could impair such protection;
Any investigations of violations or possible violations of the law;
X Any pending or anticipated litigation or contract negotiation in which the public body is or may
become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality
