## ZONING CERTIFICATES:

**Diana K Gibson – 11 Paterson Avenue – BL 19 LT 3.02** – Diana Gibson, Applicant, sworn in – will use the space as a workshop/artist's studio. May consider private lessons in the future. Motion to approve the zoning certificate by Mr. Mulder, seconded by Mr. Rau; all voted in favor except Mr. Wostbrock who recused.

**Nature's Choice Spray Foam – 231 Greenwood Avenue – BL 28 LT 1.02** – Michael Pinto, applicant, sworn in – does spray foam insulation. The space will be used for storage of products including a propane tank for a portable heater, 15-20 drums of non-flammable material, and other supplies. Motion to approve the zoning certificate by Mayor Shortway, seconded by Councilman Kruis; all voted in favor.

American Filter & Tank – 231 Greenwood Avenue – BL 28 LT 1.02 – Seth Zuidema, property owner, appeared on behalf of the tenant; sworn in – per the lease applicant has one parking space and one guest space. Office work only for the outsourcing of filter products. Motion to approve the zoning certificate subject to receipt of a completed application by Mr. Wostbrock, seconded by Mr. Rau; all voted in favor.

**The Drawing Room – 231 Greenwood Avenue – BL 28 LT 1.02** – Seth Zuidema, property owner, appeared on behalf of the tenant; sworn in – existing tenant, offering art classes. Parking requirement is included in their lease. Space is rarely occupied during the day, teaches high school students. Motion to approve the zoning certificate by Mr. Wostbrock, seconded by Councilman Kruis; all voted in favor.

Jean Claude Stone Carving – 231 Greenwood Avenue – BL 28 LT 1.02 – Jean Claude Marchionni, applicant, sworn in – is a sculptor, works along carving stone on site. Motion to approve the zoning certificate by Mr. Rau, seconded by Mr. Wostbrock; all voted in favor.

**Taskin Consulting – 231 Greenwood Avenue – BL 28 LT 1.02** – Anastasia Taskin, applicant, sworn in – office space for consulting business. Uses 1-3 parking spaces for guests. Motion to approve the zoning certificate by Ms. Pantale, seconded by Mr. Rau; all voted in favor.

Academy Builders LLC – 194 Greenwood Avenue – BL 39 LT 2 – Patrick Dobbins and Steve Early, coowners, sworn in – General Contracting/Construction Management, will be using the space for a showroom/office space and storage with a small woodworking shop in the rear. Prior work has been done in the space without building permits, which is in the process of being corrected. Mr. Berninger recommends a 90-day temporary zoning certificate to have all outstanding issued corrected and create a plan for parking; applicant and property owner have been working with the building department. Motion to approve 90-day temporary zoning certificate made by Mr. Wostbrock, seconded by Councilman Kruis; all voted in favor.
