To Whom It May Concern:

This letter is to inform you that Public Service Electric and Gas Company (PSE&G) is applying for an extension (for permit: 0000-02-0031.1) to the New Jersey Department of Environmental Protection (NJDEP), Division of Land Use Regulation for the above-referenced authorizations in association with the maintenance and installation of electric distribution facilities and vegetation maintenance activities to be performed within electric distribution and public Rights-of-Way (ROWs). If approved, the NJDEP would authorize PSE&G to disturb wetlands, transition areas, open waters, riparian zones, and flood hazard areas in order to maintain the Electric Distribution System. This letter is to provide you with legal notification that an application for the extension of a freshwater wetlands general permit and flood hazard area individual permit has been submitted to the New Jersey Department of Environmental Protection, Division of Land Resource Protection for the development shown on the enclosed plan(s). A brief description of the proposed project follows: This permit authorizes authorize PSE&G to disturb wetlands, transition areas, open waters, riparian zones, and flood hazard areas in order to maintain the Electric Distribution System, such activities include the maintenance and installation of electric distribution facilities and vegetation maintenance activities to be performed within electric distribution and public Rights-of-Way (ROWs).

The complete permit application package can be reviewed at either the municipal clerk's office in the municipality in which the site subject to the application is located, or by appointment at the Department's Trenton Office. The Department of Environmental Protection welcomes comments and any information that you may provide concerning the proposed development and site. 
