## **OPEN TO THE PUBLIC:**

The **Mayor** opened the meeting to the public for general concerns and comments.

At this time questions, concerns or comments emailed in advance to the Borough Clerk were addressed.

There were no emails to the Clerk to address.

Administrator Seemon asked individual members of the Public to speak at this time. There were no members of the public on the line at this time.

# **LIAISON REPORTS:**

**Mayor Shortway** 

**Mayor Shortway** reported he and the Administrator attended the Governor's call on October 13<sup>th</sup>.

Council President DeLuca Public Safety – Fire/Ambulance/ Personnel/Library Council President DeLuca reported progress for the Ambulance Corps, noting calendar raffle tickets are still available and can be purchased from any member and the information is on the Borough's website.

The **Council President** reported she attended the **Fire Department's** October 14<sup>th</sup> meeting: there were twelve calls for service in September, bringing the year-to-date total to 129; the department welcomes Sam Englishman as a new fireman who has transferred from Ramsey and she invited everyone to watch the Fire Department's video on the Borough's website which was sent to the schools in lieu of the annual Open House.

**Council President DeLuca** reminded everyone the **Library** will be hosting the dedication of the Story Walk in Wortendyk Park October 24<sup>th</sup> at 2 P.M. in memory of Lena Padovano. She invited all to attend the bench dedication on November 28<sup>th</sup> at 2 P.M. also in memory of Lena Padovano and noted the Library Board will be meeting Tuesday, October 27<sup>th</sup>.

Councilman Kamp Recreation/Municipal Alliance/Ridgewood Water

Due to Councilman Kamp's absence, Administrator Seemon gave the report during his report.

#### Councilman Iannone

Public Safety - Police/ Information Technology

**Councilman Iannone** reported **Information Technology** has been working on the phone system upgrade; it has been taking more time than anticipated due to COVID-19 and it's between the County and the vendors and there is progress.

The **Councilman** reported all is well with **the Police Department**: morale is high, although there has been talk of reverting back to a modified work schedule due to the rise in COVID-19 cases but they are taking it day by day and following the lead of other Bergen County police departments. **Councilman Iannone** assured everyone the Chief has this covered.

## Councilman Kruis

Planning Board/Building Dept/ Fire Prevention/OEM/Property Maintenance

Councilman Kruis reported the Planning Board meeting was cancelled due to an empty agenda.

The Councilman reported the Building Department continues to be very busy.

Councilman Kruis reported the Fire Prevention/Office of Emergency Management and Property Maintenance Official has been busy, especially with submissions for reimbursement from the Coronavirus Aid, Relief and Economic Security Act which, to date, totals \$99,573.34.

#### Councilman Sansone

Public Works/ Board of Education/ Chamber of Commerce

**Councilman Sansone** reported there will be a **Board of Education** meeting on October 27<sup>th</sup>. The **Councilman** reported progress for the **Chamber of Commerce**.

Councilman Sansone reported the Department of Public Works has been busy: disinfecting all Borough buildings daily; completed grinding 20 stumps along Godwin Avenue; finished the landscaping project in front of the Library; installed the Story Walk in Wortendyk Park and started leaf season.

#### Councilwoman Peet

#### Finance/Board of Health

**Councilwoman Peet** reported the **Board of Health** has been extremely busy with issues of COVID-19 which are ongoing 24/7 and there have been ongoing conferences with the New Jersey Department of Health.

The Councilwoman reported progress with Finance.

#### ADMINISTRATORS REPORT

Due to **Councilman Kamp's** absence, Borough Administrator Seemon gave his report: the **Municipal Alliance** has not been able to meet. **Ridgewood Water** began hydrant flushing on October 18<sup>th</sup> and it will take about two weeks to complete; Stage 2 restrictions are still in effect throughout all the municipalities Ridgewood Water services and to view the complete water quality report please go to water.ridgewoodnj.net. Mr. Seemon reported the **Recreation Department** had 125 homes signed up to hand out treats for Halloween; 10 houses were signed up for the house decorating contest, which is the most in eight years; soccer is running smoothly and the football program has had some issues with COVID-19 and the program has been shut down for two weeks.

Administrator Seemon reported the budget season is in full force and that he and the CFO have been working hard to get it in order; the purchase of the fire truck will be solidified at the next meeting and this year's leaf pick-up schedule reflects the old schedule, not the one from last year

and all information is on the website.

## Resolution #161-20 Acceptance of 2019Audit

**WHEREAS,** N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the Year 2019 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

**WHEREAS**, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the Local Fiscal Affairs, as per R.S. 52:27BB-34; and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

## General Comments Recommendations

and

**WHEREAS**, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

# **General Comments Recommendations**

as evidenced by the group affidavit form of the governing body; and

**WHEREAS**, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with at least the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

**WHEREAS,** failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 to wit:

R.S. 52:27BB-52 - A A local officer or member of a local governing body who after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

**NOW, THEREFORE, BE IT RESOLVED,** that the governing body of the Borough of Midland Park hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

## Resolution #162-20 Adopt 2019 Audit Corrective Action Plan

WHEREAS, the Director of the Division of Local Government Services has formally directed all counties and municipalities to adopt a Corrective Action Plan as part of their annual audit process; and

WHEREAS, the Corrective Action Plan shall be submitted to the Director of the Division of Local Government Services within 60 days from the receipt of the annual audit and it shall be kept on file with the Borough Clerk; and

WHEREAS, the Corrective Action Plan shall cover all audit findings and recommendations, as well as the status of prior year findings and recommendations and be prepared in accordance with the Single Audit Act, Federal and State Office of Budget Management Circular and Local Finance Notice 92-15; and

**NOW, THEREFORE, BE IT RESOLVED** that the Borough Council of Midland Park approves the attached Corrective Action Plan for the 2019 Annual Audit; and

**BE IT FURTHER RESOLVED** that a certified copy of this Resolution be forwarded to the Director of Local Government Services.

## **OLD BUSINESS/NEW BUSINESS:**

There was no Old Business to discuss.

Borough Administrator Seemon reported the Recreation Director has asked if she can sponsor a holiday collection for the Veterans' home in Paramus. He explained she usually holds a collection but the organization she donated to has disbanded and when she researched other options, she found the Paramus Veterans' home is accepting donations; the donation bins would be placed at the Recreation Center, the Library and the Borough Hall. The consensus of the Council was to approve the request.

Councilman Sansone presented a request from the Project Graduation committee for the class of 2021: they would like to hold a fall fun event to distribute the senior class sweatshirts. It would be at the Wortendyk park or the pavilion by Vander Meer field, whichever one would be available on November 22 or 23, and they would like to have music, backyard games, a barbeque and fire pits. They will take care of all the details and asked if the Borough would supply additional lighting. During the ensuing discussion, it was likened to a block party and the Council has given approval for block parties. It was also noted it would be for seniors only. The consensus was to allow the gathering.

**Council President DeLuca** invited everyone to the Veterans' Day service scheduled for November 11<sup>th</sup> at 11A.M., at Veterans' Plaza, noting all social distancing guidelines will be adhered to.

Borough Clerk Martin spoke of a new ordinance that will be on introduction for the next meeting at the request of the Police Department.
