Mayor Shortway called the Meeting to Order at 7:00 P.M.

## **DISCUSSION ITEMS**:

Estimated Tax Bills & Tax Levy Calculation- Both Deputy Tax Collector, Kalata and Tax Collector, Miller explained the reason for the estimated tax bills and how the calculation will be determined. Councilman Sansone asked if we do estimate tax bills will each property owners be receiving a letter. Deputy Tax Collector Kalata stated all property owners will be receiving an estimated amount for the third quarter. In September the accounts will reconciled with the rate the Borough receives from Bergen County and tax bills with the fourth quarter of 2020, first & second quarter of 2021. Tax Collector, Miller stated the third quarter estimation does not necessarily have to be a letter, it will most likely be a bill

in October. **Council President DeLuca** inquired how the mortgage companies handle the estimated taxes. **Tax Collector, Miller** responded that generally the banks do escrow analysis of each of their properties and have an idea of what the taxes will be for the coming year. The banks will all receive the estimated amounts and will pay. **Councilwoman Peet** asked if there was any indication of what the school taxes will be. **Deputy Tax Collector Kalata** stated the local school's numbers are from their adopted budget along with the numbers provided from CFO O'Hanlon which are the Library, Municipal, and Municipal Open Space, what we are estimating are the County and County Open Space. **Attorney Regan** made a recommendation suggesting sending out a letter otherwise the Borough may be inundated with calls, a letter may mitigate some of the concerns. **Borough Clerk Martin** asked **Tax Collector, Miller** how she is handling this in Glen Rock. **Tax Collector, Miller** stated a brief blurb will be included on the estimated bill, she will confirm with Edmunds. The consensus of the Mayor and Council was to proceed with estimated tax bills and to use the 105% for the calculation.

Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy;

Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body (Specify

contract):

Any matter involving the purpose, lease or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed;

J. 478, the employee(s) and nature of discussion is **Recreation Summer Camp.** 

Any deliberation of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party as a result of an act of omission for which the responding party bears responsibility;

**BE IT FURTHER RESOLVED,** that the Borough Council hereby declares that its discussion of the aforementioned subject(s) may be made public at a time when the Borough Attorney advises the Borough Council that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the Borough, or any other entity, with respect to said discussion.
